## MONITORING, EVALUATION AND PERFORMANCE MANAGEMENT POLICY

#### Rationale

Performance management means a shared commitment to high performance. It helps to focus attention on more effective teaching and monitoring to raise the quality of teaching and to benefit tutors, students, and the organisation. It means providing appropriate and effective personal training and development to ensure job satisfaction, a high level of expertise and professional development.
